Preface

Bangladesh is one of the most disaster-prone countries in the world due to its geographical location. The frequency and intensity of disasters have been increased in recent years due to climate change as floods and storm surges are likely to become more severe with increases in intense tropical cyclones. Also, Geographically the country is located close to active seismic zone and susceptible to medium to large earthquakes. These disasters cause not only direct physical damages to the lives and assets, but also indirect and consequent losses to various sectors such as agricultural sectors, food security, water, health and sanitation, significantly impacting economy and livelihood of the local communities. To tackle the situation, the government has achieved breakthroughs in disaster risk management by mentioning this as one of the top priorities, as described in the 8th Five Year Plan (July 2020- June 2025) "a sustainable development pathway resilient to disaster and climate change" as a core theme.

In order to accelerate the disaster resilience of the country, it is vital to develop and implement local disaster risk reduction strategies and plans as also indicated in the Sendai Framework for Disaster Risk Reduction 2025-2030. Expectedly, by adopting a local disaster risk reduction plan in every Upazila, it is possible to effectively reduce the damage and loss caused by disaster, and enhance continuous and sustainable development of the country's economy and therefore achieving Vision 2041 of the government.

In light of this, "The Project for Capacity Enhancement on Formulation and Implementation of Local Disaster Risk Reduction Plan" has been implemented since December 2020 led by MoDMR and DDM, supported by the Japan International Cooperation Agency (JICA). In this Project, Upazila Disaster Risk Reduction Action Plans have been formulated in six pilot Upazilas of three districts, which are Cox's Bazar (Cox's Bazar Sadar and Chakria), Sunamganj (Chhatak and Jagannathpur) and Kurigram (Chilmari and Ulipur). These plans have been developed by unique approaches that are 1) Scientific analysis for local hazards; 2) Setting DRR targets based on risk quantification; 3) Involvement of project implementing agencies including BWDB, LGED, SoB, GSB, BMD, PWD, FSCD, and so on. These approaches have successfully established this effective plan and promote to execute projects to reduce disaster risk.

This plan is expected to save lives, livelihoods, and resources of the Upazila, as well as pave the way for the enhancing future development through disaster risk reduction in the country.

While Bangladesh is advancing rapidly on the path of development, natural disasters are hindering the ongoing dynamic development of Bangladesh. Although Bangladesh is disaster-prone due to geographical reasons, climate change adds insult to injury as one or the other disaster strikes the nation almost every year. Sunamganj district, which consists of twelve Upazilas and four municipalities, is rich in various high-quality mineral resources such as sand, limestone, pebbles, and coal, as well as a major source of the country's fishery. While such natural beauties attract local and foreign tourists throughout the year, the district is at risk of disasters due to its geographical conditions such as the adjacency to Meghalaya Hill, and low-lying areas surrounded by Haor and the backward district as located in the foothills of Meghalaya, India. Disasters, especially flash floods, occur almost every year in Sunamganj and adversely affect the lives and livelihood of the people. Due to the flash flood, only one crop of Boro paddy in a year gets lost, and hence the farmers face difficulty to harvest the crop timely. Last few years, the Government of Bangladesh has focused on disaster risk reduction and disaster preparedness, in addition to the post-disaster relief and rehabilitation. "The Project for Capacity Enhancement on Formulation and Implementation of Local Disaster Risk Reduction Plan", which is led by the Ministry of Disaster Management and Relief (MoDMR) and the Department of Disaster Management (DDM) with the support of JICA and is piloting in two Upazilas - Chhatak and Jagannathpur of Sunamganj district, is one of such initiatives. Sunamganj district is known throughout the country as Haor and low-land area. Fishes, Stones and Rice are recognized as the soul of the district. Upazila Nirbahi Officer Jagannathpur, Sunamganj

Chapter-1. Introduction

1.1 Purpose and aim of the Plan

The purpose of the Jagannathpur Upazila Disaster Risk Reduction Action Plan (UzDRRAP) is to identify necessary countermeasures against natural disasters and implement them in cooperation with relevant stakeholders to reduce disaster risks in the Upazila. This Plan contributes to increasing investment in disaster risk reduction by ensuring a mechanism for project implementation of the line ministries' countermeasures and by promoting further funding from agencies.

1.2 Rationale for the formulation of the Plan

This Plan corresponds to the Risk Reduction Action Plan (RRAP) that is required to be developed as a part of the Disaster Risk Management Plan (DRMP) by Disaster Management Committees (DMC) at District, Upazila and Union DMCs, according to the Standing Orders on Disaster 2019 (SOD). In the SOD, it is recommended to prepare RRAP by local DMCs, as well as the Contingency Plan. While the disaster response which is covered by the Contingency Plan has been relatively conducted as required in emergencies, risk reduction measures based on the objective hazard and risk assessment had not been sufficiently implemented at the Upazila level. In consideration of this situation and the importance of the DRR investment for the further development of the country, this plan, therefore, emphasises disaster risk reduction and proposes the necessary actions as a master plan corresponding to the RRAP of the Upazila Disaster Management Plan (UzDMP), which directly leads to the preparation of Development Project Proposals (DPPs) and Annual Development Programmes (ADPs).

The formulation of the UzDRRAP and the implementation of the countermeasure against disasters are in line with government strategies, policies, and plans of the country, as listed below.

- The Bangladesh Delta Plan 2100 mentions the importance of strengthening the disaster risk management and combating the effects of climate change.
- 8th Five Year Plan (July 2020-June 2025) emphasizes appropriate policy and institutional capacity building to address their concerns on climate-resilient development and disaster management at all levels of the government, especially at the local government level where most of the programmes are to be implemented.

 The National Plan for Disaster Management (NPDM 2021-2025) focuses on "Making disaster risk reduction a development practice to achieve resilient public investment and the SDGs" and "Building capacity and leadership to implement NPDM 2021-2025 at the national and local level".

In addition, from an international perspective, this plan directly contributes to the Sendai Framework for Disaster Risk Reduction 2015-2030 (SFDRR), specifically the Target (e) "To substantially increase the number of countries with national and local disaster risk reduction strategy".




Figure 1-2. Relationship between national key policies and this plan

1.3 Relevance to other Upazila plans

Based on the Local Government (Upazila Parishad and Upazila Administration Reorganization) Act 1998 and the Local Government (Upazila Parishad) Act 2009, each Upazila shall prepare a development plan and land use plan. This plan and the proposed countermeasure against the disasters has been considered to ensure consistency with these plans in this Upazila.

1.4 Features of the Planning

The features of this Planning are 1) Scientific Analysis for Local Hazards, 2) Setting DRR Targets based on Risk Quantification, and 3) Involvement of Project Implementing Agencies, which are expected to contribute to the actual execution of the effective countermeasures.

Feature 1: Scientific Analysis for Local Hazards:

The hazard maps were developed by simplified technical analysis, which processes are not adopted in the Community Risk Assessment (CRA), using observed disaster records of rainfall and tidal level, the Digital Elevation Model (DEM), and current hazard maps. The developed hazard maps represent the vulnerable areas of the Upazila and help promote to objectively understanding of the hazard potential.

Feature 2: Setting DRR Targets based on Risk Quantification:

Risks in this Upazila were quantified based on risk quantification using the hazard maps and various factors such as natural conditions and socio-economic factors and visualized to share with relevant agencies. A DRR target was set in consideration of the result of identifying which areas are highly affected by potential hazards, by these risk quantifications.

Feature 3: Involvement of Project Implementing Agencies:

The Upazila Sub-Committee (UzSC), which is composed of the Upazila chairman, UNO, PIO, engineers from LGED, BWDB, and DPHE in the Upazila, Upazila officials, Union Parishad chairman, was established to identify disaster risks and consider priorities of countermeasures against the disasters at the Upazila level. Since the committee at the Upazila level does not have the authority to determine the countermeasures listed in the plan to be implemented, the members from the line ministries at the central level are involved in the planning processes to promote the schemes/projects listed in the UzDRRAP and secure budgets.

1.5 Methodology for the development of the Plan

1.5.1 Institutional Arrangement

For the development of this Plan, an UzSC, that is stipulated in the SOD, was established in this Upazila. The roles and responsibilities of this committee are to:

- Prepare this UzDRRAP by identifying existing DPPs and pipeline projects related to DRR, Union Parishads (UPs) priority, some development projects that might affect people or increase disaster risk;
- Summarize DRR projects by examining needs of UPs and Risk Reduction Action Plans developed by UPs;
- 3) Identify possible DPP to be able to collaborate among line ministries on structural and non-structural measures to maximize the efficiency and effectiveness of DRR.

In addition to this UzSC at the Upazila level, Technical Sub Committee (TSC) was established to coordinate projects proposed by other Upazilas in addition to Jagannathpur Upazila at the central level, implementation of the projects proposed in the UzDRRAP are determined by the line ministries at the central level. The roles and responsibilities of this TSC are to:

- 1) Summarize and monitor the progress of DRR related projects based on the plans that UzSCs submitted:
- 2) Request line ministries on the possibility to do further investigation on DRR project needs . based on the UzDRRAP;
- 3) Make efforts to integrate DRR ideas into DPP, ADP and 5YP in Upazila and line ministries, considering disaster risk reduction target in the UzDRRAP;
- 4) Discuss among line ministries on development projects which might affect people or cause disaster;
- 5) Establish the guidelines and manuals to prepare Upazila Disaster Risk Reduction Action Plans
- 6) Take an initiative to start up UzSCs for the preparation of UzDRRAPs.

1.5.2 Planning Process and Methodology

This plan was established based on a combination of methods, namely JICA 8 steps and the CRA method which has been broadly utilized as a vulnerability assessment in the country, as shown in the figure below.

For developing each chapter of this plan, the following methodology was introduced.

Chapter 2: Geographic, Socio-economic, and Meteorological Conditions

This chapter illustrates the characteristics of the Upazila, that is the conditions to develop the Action plan for DRR. The statistics data including the Census 2011 and meteorological data was collected and analyzed.

Chapter 3: Target Hazards and Disaster-prone Areas

This chapter explains the disaster records, target hazards, as well as disaster-prone areas by showing hazard maps. While disaster records of the Upazila were collected by the DRRO of the district or online media sources, disaster-prone areas were identified through scientific analysis by utilizing data such as elevation data (DEM), probability rainfall data and so on. the BWDB's pre-monsoon danger level was considered. These hazard maps were then confirmed in workshops where the UzDMC members participated.

Chapter 4: Disaster Risk and DRR Targets of the Upazila

This chapter describes the estimations of damages caused by each hazard. The damage estimations of flood target paddy fields, settlement areas, as well as the important public facilities and infrastructures, while those for earthquake shaking target households. These damages were estimated by overlaying hazard data with statistical data¹, and consequently confirmed by the UzDMC members and the UzSC members in workshops and meetings, along with the priority unions that were set by such disaster risk.

Chapter 5: Action Plan of DRR Countermeasures

This chapter shows the current status and issues of the countermeasures as well as the necessary projects for DRR. The current status of the countermeasures was identified and analyzed by consultation with UzDMC and UzSC members, while the necessary projects were proposed by the UzDMC members. The proposed projects were then validated with line agencies, and prioritized with UzDMC and UzSC members.




Figure 1-3. "8 Steps" for Upazila DRR Planning in case of this plan

Chapter-2. Geographic, Socio-economic, and Meteorological Conditions

2.1 Location and Geographic Conditions

2.1.1 Location of the Upazila

Jagannathpur Upazila is situated in the south-east of Sunamganj district and the middle of the divisional town, Sylhet, of the north-east part of Bangladesh. It is bordered by Chhatak Upazila to the north, Shantiganj Upazila to the north-west, and Derai Upazila to the south-west under Sunamganj district and Bishwanath and Osmaninagar Upazila under Sylhet District to the east and Nabiganj Upazila under Habiganj District to the south. It is located 50 km west of the divisional headquarters city of Sylhet and 43.3 Km north-east of the district town Sunamganj. The area of the Upazila is 335.97 km².

2.1.2 Topography of the Upazila

The topography of Jagannathpur Upazila consists primarily of flat and low-lying plains with an elevation of less than 12 meters except for the high area comparatively. Therefore, the Upazila is vulnerable to flood and flash flood due to monsoon frequently. These flat areas are used for agriculture, fish and duck farming in the haor area, fishing in the open water body and settlement.

2.1.3 River System of the Upazila




Figure 2-3. Major River, Small Rivers and Haors in Jagannathpur Upazila

Sunamganj District has a major river, which is Surma River. Surma River originates in India, called as Barak River, and runs into Bangladesh through Assam, India (Figure 2-3). Barak River is divided into two rivers, which are Surma River running through the northern area of Sunamganj District and the Kushiyara River, connecting into Kalni River running on the south edge of the said district. Those rivers run into Meghna River, which is one of the major rivers in Bangladesh. The Meghna River's catchment area and its length are, approximately, 82,000 km2 and 950 km, respectively. Of the total catchment area and its length, approximately 35,000 km2 and 670 km are situated in Bangladesh. Surma River and Kalni River play the essential role of water resources in Sunamganj and those are utilized as resources of drinking water, irrigation for agriculture and fishery.

The Surma River flows through Chhatak Upazila and Kalni River runs through Jagannathpur Upazila. In those upazilas, there are some wetlands called "Haor" and those rivers provide water into Haor from the mountainous area.

According to the study by BWDB, there are three seasons' categories based on the precipitation patterns in the area, which are dry season, pre-monsoon season and monsoon season. The pre-monsoon season starts on March 15th and lasts until May 15th. The monsoon season follows the pre-monsoon season and continues until the end of October. The rest, from November to the middle of March is called the dry season. During the monsoon season, flooding occurs a lot along those rivers and the Haor area becomes deeper and wider.

2.2 Socio-economic Conditions

2.2.1 Demography

Jagannathpur Upazila is divided into eight unions: Asharkandi, Chilaura Holdipur, Kolkolia, Mirpur, Pailgaon, Raniganj, Syedpur Shaharpara and Patli. Jagannathpur Paurashava is divided into 9 Wards and 43 Mahallas. The demography in Jagannathpur Upazila is shown below. According to the census 2011, the total population of the Upazila is 287,786 people.

2.2.2 Economy and Industry

The economy of Jagannathpur Upazila is mainly depends on agriculture and agriculture-based farming. Out of total 41,958 households of this Upazila, 63.58% households are directly related to agriculture farming. They produce various crops mainly rice (Amon and Boro), wheat, vegetable, oil seeds and others which are sold both locally and to other parts of the district. Apart, fishing in open water body along with fishery in the wetland, Haor, Beel and even in the paddy field during the rainy season are the important economic activities of the area. Besides, Livestock, Duck farming, and Cottage industries (e.g., Bamboo and Cane work) are also the main sources of household income of this Upazila. There are a number of Fisheries, Dairies, Poultries and Duck hatcheries in this Upazila. The main export item from this Upazila is haor fish. Non-farm activities are not very much significant in this Upazila. Although males and females are equally involved in agriculture, female participation in non-farm activities is very much poor in rural areas.


According to the district statistics (2011), agriculture contributes to economy 57.11%, non-agriculture sectors 6.87%, industry 0.42%, trade 9.42%, transport & communication 0.96%, remittance 9.70%, service 3.79%, construction 0.88%, religious service 0.34% and others 10.51%.

The following table shows the total establishments of different industries in Jagannathpur Upazila which are contributed to the national economy.

2.2.3 Urbanization

The urbanization rate (population living in the urbanized area) in Sunamganj district is relatively low compared to the average rate of Bangladesh of 31.51% (Population & Housing Census 2022). By the comparison of 2001 and 2011, the urbanization rate was increasing in the upazila of Chhatak, Derai, Jagannathpur and Sunamganj Sadar. The urbanization rate in Jagannathpur is 15.68 % in 2011 and the rate has expanded for 0.2 % which is not a significant increase. The highest urbanization rate observed in the Sunamganj district is 25.13% in Sunamganj Sadar. However, Jagannathpur upazila is one of the upazilas where urbanization is developing as Jagannathpur Paurashava is located as a growing center. Annual population growth rate in Jagannathpur upazilla is 1.08% in 2022 according to the comparison between 2011 and 2022, it is slightly lower than the average rate of Bangladesh of 1.22% (Population & Housing Census 2022). Annual population rate in the union of Asharkandi, Kolkolia and Chilaura Holdipur above the average of the upazila, which is one of the criteria to indicate the urbanization in these unions.

2.3 Meteorological Conditions

Syedpur Shaharpara




Figure 2-5. Average Annual Rainfall and Temperature

The climate of Jagannathpur Upazila, or Sunamganj District widely, is dominated by the tropical monsoon and is distinguished in 2 seasons: a rainy season and a dry season. The southwest monsoon brings the rainy season from April to October as shown in Figure 2-5. Then, the northeast monsoon flows and dries the area from November to March.

As shown in Figure 2-5, the Upazila has an annual rainfall of more than 2,000 mm. Most rainfall is concentrated during the rainy season, especially the 4 months between June to September, when a third of the annual rainfall occurs. Also, there is moderate rainfall in May and October. The heavy rainfall often devastates haor area of Jagannathpur Upazila and causes flooding in the area. In addition, flash flood also generally affects in late March to mid-April due to rainwater comes from upstream. Also, the thunderstorm causes tremendous damage for which may people dies in every year.




Figure 2-6. Average Temperature

The Upazila has a little high temperature in comparison with the national average. The highest temperature reaches a maximum of 35.0°C in April and a minimum of 16.0°C in January. From February to October the temperature is prevailing within 30.0°C to 35.0°C (Figure 2-6).

Chapter-3. Target Hazards and Disaster-prone Areas

3.1 Disaster Record of the Upazila

Jagannathpur Upazila has experienced several disasters affecting the lives and livelihoods of the local communities, due to its topography and meteorology. The table below shows the disaster records in this Upazila. One of the most historic and destructive disasters was the 2022 flood which severely affected the Upazila with over 6,000 damaged houses and 50,000 affected people.

3.2 Target Hazards of this Plan

Apart from the above, there are several types of other disasters that can also cause damage to this Upazila. This Plan targets all the possible disasters in the Upazila including lightning and drought, whereas it objectively and scientifically analyzes the following disasters with high damage potentials and shows hazard maps to identify the hazard potential in the Upazila.

- Flood
- Earthquake Shaking

3.3 Hazard Map and Disaster-Prone Areas by Each Hazard

3.3.1 Flood




Figure 3-1. River Floods Hazard map in Jagannathpur Upazila

Figure 3-1 shows a flood hazard map for Jagannathpur Upazila, targeting the pre-monsoon flash flood, which causes tremendous damage on the paddy production (cultivation). The flood hazard map was created utilizing danger water levels defined by BWDB. The danger water level is designed to be the water level above which the flood may cause damages to nearby crops and homesteads. It was fixed slightly below the design flood level of the embankment, and it was also applied to submergible embankment height. In terms of the probability of occurrence, corresponding return period is approximately 2.33 years of the pre-monsoon season.

Among the unions in Jagannathpur Upazila, Asharkandi, Chilaura Holdipur, and Kolkolia are particularly prone to flooding because the lands of such unions are low-lying and some hoars are located. The paddy fields and the settlement area in such unions are affected severely and widely.

3.3.2 Earthquake Shaking




Figure 3-2. Earthquake Hazard map in Jagannathpur

Figure 3-2 shows an earthquake shaking hazard map for Jagannathpur Upazila. The earthquakes in Sunamganj District can be mainly caused by the collision of the Indian and Eurasian tectonic plates, which creates a complex fault system in the region. The northwestern unions including Kolkolia and Chilaura Holdipur Unions, are estimated with relatively weak shaking rather than other unions.

Chapter-4. Disaster Risk and DRR Targets of the Upazila

4.1 Disaster risk

4.1.1 Flood

The flood risk in the Upazila was estimated focusing on three major assets to be protected: cultivation field, settlement areas as well as important infrastructures and public facilities. By overlaying the flood hazard map on these areas, the affected areas can be identified.

In general, the countermeasures against floods include 1) river and canal improvement such as construction of embankments, dredging and widening to increase flow capacity, 2) construction of retarding basins/reservoirs to temporarily store a portion of flood water, and 3) drainage improvement such as installation of sluice gates and pumping stations to drain the flood water to nearby rivers.

(1) Damage estimation of paddy field affected by flood




Figure 4-1. Inundated Paddy Field with danger water level of BWDB




Figure 4-2. Inundated Area of Paddy Field with danger water level of BWDB

As shown in Figure 4-1 and Figure 4-2, the most vulnerable unions to flooding are Chilaura Holdipur and Kolkolia Unions adjacent to Pingla Haor. The inundation areas are approximately 3,050 m^2 and 3,150 m^2 , respectively. 82% of Asharkandi Union, located on the southeastern corner of Jagannathpur Upazila is also affected by flooding as it is adjacent to the Chalyyar, Saratir and Dayalang Hoars.

Total Economic loss estimated based on the areas of the inundated paddy fields, reaches about 864 million Taka. Kolkolia Union is most affected with about 263 million, followed by Chilaura Holdipur Union with 255 million Taka. Asharkandi Union will be most affected in terms of the percentage with 82.1% of the paddy field inundated.

On the other hand, the below map shows the inundation risk areas in case that the submergible embankments properly work. In this case, while inundation risk in Chilaura Holdipur and Kolkolia Unions adjacent to Pingla Haor are significantly reduced by the embankments, there are some unions whose inundation risks remain. These remaining risk areas are currently not covered by BWDB's Haor sub-projects and not adequately equipped with other structural interventions to prevent or mitigate the impact of pre-monsoon flash flood. In particular, in Asharkandi Union, the remaining inundation affected area (≥ 0.3 m) is estimated at 1,963 m².




Figure 4-3. Inundated Paddy Field in case of functioning submersible embankment




Figure 4-4. Inundated Area of Paddy Field in case of functioning submergible embankments

(2) Damage estimation of settlement area by flood




Figure 4-5. Inundated Settlement with danger water level of BWDB

Figure 4-5 shows that portions of the settlement areas of Kolkolia, Chilaura Holdipur and Asharkandi Unios which are adjacent to some haors are affected by flooding.

Comparing the affected settlement areas by union, Chilaura Holdipur and Kolkolia Unions are the most affected with approximately 7,590 m^2 and 6,500 m^2 , respectively. These unions are located comparably lower elevation areas, thus more prone to flooding. The flooding depth in the Upazila ranges from 0.3 m to 3.6m in most areas, widely depending on the topographic conditions.




Figure 4-6. Inundated Area of Settlement with danger water level of BWDB




Figure 4-7. Affected Population with danger water level of BWDB

For both the number and percentage of the population, Chilaura Holdipur Union is most vulnerable to flooding (Figure 4-7 and Table 4-2). The population of Kolkolia Union is also vulnerable to flooding. These unions are in located comparably lower elevation areas, thus more prone to flooding.

(3) Damage estimation of important facilities and infrastructures by flood




Figure 4-8. Inundation map by flood with DRR-related facilities and infrastructures²

Figure 4-8 and Table 4-3 illustrate the damage estimation of the DRR-related important facilities and infrastructures, namely roads and bridges, government offices, schools and shelters, and hospitals, in consideration of the disaster management and emergency operation. As the Figure and the Table show, roads and public facilities in Chilaura Holdipur Union, are relatively severely affected by the flood. The union is located comparably lower elevation area, thus more prone to flooding.

4.1.2 Earthquake Shaking




Figure 4-9. Number of Affected Households

The risk of earthquake shaking is high due to inadequate seismic resistant buildings in Jagannathpur Upazila. Figure 4-9 and Table 4-5 show that Jagannathpur Paurashava having the largest population in Sunamganj District, is most affected by the earthquake shaking, followed by Raniganj and Kolkolia Unions. The ratio of the affected households is highest in Kolkolia Union.

In general, the earthquake resistance measure is to strengthen the buildings, which depends on the economic conditions of each government and household.




Figure 4-10. Building Damage Degree

4.2 Priority Unions for Disaster Risk Reduction




Figure 4-11. Relation between Affected Area or Population and its Ratio

Based on Chapter 4.1, priority unions were identified by disaster. According to the relation between the affected area or population and its ratio in Figure 4-11, the identified priority unions by disaster are shown in Table 4-6. Kolkolia is included in priority unions of both flood and earthquake shaking since it has relatively a much larger affected population and lands compared with other Upazilas.

4.3 Disaster Risk Reduction Target

In the risk analysis in Chapter 4-1, the damages by disaster have been calculated. In consideration of this objective estimated results, the target to reduce disaster damages is set as follows.

[Disaster Risk Reduction Target - Mission]

The estimated human and economic damages by each disaster are reduced by 50% within 10 years (from 2023 to 2033).

In order to accomplish the above mission effectively with the limited budget and human resources, the following concrete countermeasures and areas were identified as prioritized areas, based on the risk assessment result identified in Chapter 4-1 and 4-2, as well as consultation results with the UzSC members.

Chapter-5. Action Plan of DRR Countermeasures

5.1 Current Status and Issues of the Structural and Non-Structural Countermeasures

The implementation status of each type of DRR countermeasures in this Upazila was summarized in the table below. As the table shows, most part of the flood prevention has been addressed by BWDB and LGED while some countermeasures for earthquake shaking have not been covered enough by governmental agencies. These infrastructure projects for protection and control against floods have contributed to reducing inundation in the long term in this Upazila. Meanwhile, infrastructure projects such as road construction, water supply and sanitation, and shelter have contributed to reducing the secondary effects of flood disaster, helping to enhance the capacity of disaster response. It is further required to accelerate the structural and non-structural countermeasures that have been currently implemented in the Upazila, as well as to initiate promoting the coordination and discussion among related agencies to introduce countermeasures that have not been undertaken or unknown in the Table below.

5.2 Prioritized projects for DRR Target

In consideration of the hazard and risk assessment results in Chapter 3 and 4 as well as the current status and issues of the DRR countermeasures in Chapter 5.1, this Chapter describes the policies of DRR countermeasures by category. Furthermore, along with the strategy, concrete proposals of the DRR countermeasures are collected from the communities and implementing agencies, analyzed and prioritized by category, which are shown in the Attachment including the prioritization (priority unions) with red highlights. The processes to propose these projects were as follows.

- a) The needs of Union Parishad were organized at the LDRRP development workshop held from November 2022 to February 2023.
- b) Existing projects, pipeline projects, and new projects of the implementing agencies were identified at the workshop and by collecting information from the implementing agencies.
- c) Information on Union Parishad's needs from the line ministries was reviewed and the correspondence between their projects and Union Parishad's needs was validated.

With the aim to achieve the DRR target (Mission), the UzSC will encourage the project implementing agencies to include the proposed projects in their own plans and to implement them.

The legend of the proposed project list (See the Attachment 1) is shown below.

5.2.1 Prioritized Structural Countermeasures

(1) Infrastructures for Protection and Control against flood

As shown in the flood hazard map in Chapter 3.1.1. and the flood risk assessment results in Chapter 4.1.1, Asharkandi is the most flood prone Union due to its location and low-lying condition. In order to reduce flood disaster risk in this Upazila, in terms of protecting agricultural property in a way that is compatible with its unique hydrological characteristics as well as people's livelihood, development of submergible embankment and its ancillary work should be considered with higher priority. In order to mitigate the damage to settlement areas and critical infrastructures, strengthening the flow carrying capacity of Kushiyara River and other main channels with embankment and other improvement works are also important. Apart from them, drainage management works including sluice gate and canal excavation in flood prone areas such as Chilaura Holdipur, Mirpur and Kolkolia are also highly required. The category of the project for flood prevention and mitigation are shown below. Although there are some types of countermeasures that have not been proposed by communities and line agencies currently, it is necessary to clarify the responsible agencies and implementing policies and to subsequently take actions to implement them.

- a) Embankment/dyke
- b) Other river improvement (e.g., Widening and Deepening)
- c) Sluice gates
- d) Retarding basin/reservoir
- e) Drainage Facilities (e.g., Pumping Station)
- f) Rubber Dam.

The map below shows infrastructures for flood prevention and mitigation. The areas where the higher priority are put as DRR targets are the high-risk area highlighted in red (shown in Chapter 4). The proposed project list of each countermeasure by category are shown in Attachment 1.

In addition, there is a possibility that there will be a flood of a magnitude greater than the target level of the flood in the Plan. In such an event, it will be important to protect human life by expanding non-structural measures (see Chapter 5.2.2 for more detail).

Also, in the future, flood management infrastructure projects should be developed at a higher safety level than that is adopted in the Plan from a long-term perspective. It might be necessary to establish a safety level, which should be determined according to the development status of the region. Possible measures to achieve such a higher safety level include further widening of main channels, diversion of flood waters through construction of diversion channel and reduction of flood flows through construction of retarding basin in the upper reaches of the river, in addition to the development of said non-structural measures. The possibility of these measures should be examined taking into account the hydrological, topographic and geological characteristics of target areas as well as social and environmental conditions.




Figure 5-1. Priority Union for Countermeasure to Reduce Risk by Flood

(2) Structural Measures against Earthquake Shaking

- a) Compliance with the building code (BNBC-2020)
- b) Building Assessment (Seismic Diagnosis)
- b) Retrofitting of important facilities and infrastructure

There is no proposed project for structural measures against earthquake shaking by line ministries and communities so far. However, the seismic diagnosis as well as retrofitting of existing important facilities (e.g., schools, hospitals, shelters) and infrastructure (e.g., bridges, roads, embankments/dykes) are required in advance, for saving lives and evacuation during and after the earthquakes. At the same time, it is significant to promote complying with BNBC2020 with official instructions and monitoring when constructing new buildings.

(3) Infrastructures for Emergency Operations

According to the risk assessment results, Asharkandi, Mirpur, Chilaura Haldipur, Jagannathpur Paurashava, Raniganj, Kolkolia unions are relatively high-disaster-prone areas in this Upazila. Although emergency operations are significant in all Upazilas and should be functional in the whole of the administrative area, this plan prioritizes to propose the improvement of the infrastructures for emergency operations in such highly disaster-prone areas first. Specifically, shelters need to be sited in safer sites and have the capacities of all expected evacuees in each above union. It is also significant to consider introducing multi-purpose shelters that can be utilized as schools and community centers in normal times, when newly constructing or maintaining shelters. Regarding public infrastructures, main roads and bridges connecting important facilities between unions, such as Aserkandi UP-Kalnirchar Bazar Road (LGED-ID: 690473017), and the 3 Nos. bridge in different Chainage [Ch:1+450 km,Ch:2+200 km,Ch:3+750 km] at Aserkandi UP-Kalnirchar Bazar (LGED-ID: 690473017), should be constructed or appropriately maintained with sufficient widths for emergency operation during the disasters. The improvement of culverts, drains, and other facilities for water is also necessary in inundation-prone-areas to drain the water to mitigate the stagnant water, which leads to smooth recovery and to consequently mitigate infectious diseases.

The category of the project for infrastructures for emergency operations is shown below;

- a) Shelters
- b) Roads
- c) Bridges
- d) Culverts
- e) Drains
- f) Facilities for water (e.g., Tube well, pipeline and sanitation (Latrine))
- g) Other infrastructures and facilities for emergency operations

The map below shows Infrastructures for emergency operation, highlighted in red are the high-risk areas where this plan puts priority as DRR targets (shown in Chapter 4). The proposed project list of each countermeasure by category are shown in Attachment 1.




Figure 5-2. Location of Infrastructures for emergency operation

(4) Infrastructures for Prevention of Other disasters

a) Lightening Conductor

There are few projects for improving infrastructures for prevention of lightning damage that were proposed by line ministries and communities. These projects are shown in the Attachment 1.

5.2.2 Needed Non-Structural Countermeasures

There are some non-structural countermeasures that have been relatively promoted in the Upazila, specifically early warning information and communication and raising public awareness and disaster education as shown in the Chapter 5.1. However, in consideration of the possibility of large-scale disasters as well as the residual (remaining) risks of proposed structural countermeasures, it is required to promote improving non-structural countermeasures, specifically evacuation plans (e.g., consideration of the location of the shelter and its capacity, evacuation roads) and early warning systems, at the same time with structural countermeasures. In addition, although land use regulations and controls have not been often seen in this Upazila, such drastic approach should be considered especially in severe high-disaster risk areas. The category of the non-structural countermeasures is shown below.

(1) Land use planning (Upazila/UDD)

- a) Urbanization Control
- b) Resettlement
- c) Designating Special Warning Area

(2) Early Warning Information and Communication (BWDB/DDM/FFWC/BIWTA etc.,)

- a) Installation of Monitoring System of Rainfall and Water level
- b) Flood Forecasting and Warning System, including community radio
- c) Telecommunication system for search and rescue

(3) Disaster Management Training and materials

- a) Preparation of SOP for emergency operation (DDM)
- b) Simulation and exercise (DDM/FSCD)
- c) Evacuation drill/shelter and evacuation route (DDM/FSCD)
- d) Training on DRR (DDM)
- e) Preparation for the emergency operation (DDM/FSCD/DGHS)

(4) Raising Public Awareness and Disaster Education

- a) Publication of DRR Maps (DDM)
- b) Inventory preparation on vulnerable infrastructure (PWD/ DMC)
- c) Disaster preparedness education in schools (DoPE/DoEE)
- d) Awareness session on disaster, including Celebrating day's observation on disaster (DDM)
- e) DRR awareness related billboard (DDM)

(5) Other non-structural countermeasures

There are some projects related to the above countermeasures that were proposed by line ministries and communities, which are shown in Attachment 1. In order to further promote disaster risk reduction in the collaboration of structural and non-structural countermeasures, it is necessary to also clarify the responsible agencies and implementing policies of the non-structural measures that had not been implemented or even proposed, and to subsequently take actions to execute them.

5.3 Monitoring and Updating of the Plan

For the appropriate implementation of the projects by project implementing agencies, this plan is to be monitored and updated by UzSC supported by TSC in the following steps.

Step 1: The UzSC in coordination with TSC will check the status (rate of progress) of the prioritized project annually, one year and two or three years after their development.

- Step 2: The TSC will confirm the effectiveness of existing projects and the need for new proposed projects including the proposal mentioned in Chapter 5.2 and Attachment 1.
- Step 3: For those areas where the need for feasibility studies has been identified, the implementing agencies will hold preparatory discussions for the preparation of a DPP, including obtaining the budget for feasibility studies, and report back to the TSC.
- Step 4: Based on the findings after the TSC meeting, the UzSC will re-examine the need for new proposals once a year.
- Step 5: If any changes are identified, the UzSC will update the plan.

The conceptual model of the monitoring and updating the plan is proposed as shown below.




Figure 5-3. Conceptual diagram for monitoring and updating the plan
